- 3. I voluntarily agreed to participate in the questioning and the giving of this declaration, I understand that I can stop questioning and the giving of this declaration at any time.
- 4. My employer's management personnel were not present during the questioning and giving of this declaration.

5. I am employed as a safety coordinator for a continuous continuous california

- 6. All of the information provided below is true and accurate to the best of my personal knowledge. I understand that providing false statements within this declaration is a crime and subjects me to criminal prosecution and possibly imprisonment.
- 7. As to the subject of my interaction with Mr. Hall, I hereby testify as follows based on the facts known to me:
- 8. On the night of 2/28/2017, I was staying at the Hyatt Regency Hotel in Sacramento, because I attended the Fresh Fruit Association's Government Relations Meeting. I attended the meetings in the daytime, and the reception in the evening. I first talked with Isadore Hall, at the reception party that evening, and he had told me he would like to further speak with me, about my views on worker issues in agriculture. I gave him my business card, and figured we would speak again, in the future.
- 9. Later that evening as I left my room in the Hyatt Regency Hotel, I came across a group of members from the Fresh Fruit Association, and as I came upon them realized they were speaking with Mr. Hall. I heard Mr. Hall cussing quite a bit, being very loud, and decided I would not stay, nor get involved in the discussion going on.
- 10. So I ordered a drink, and as I was going towards the back exit to smoke a cigarette, when Mr. Hall walked out in front of me. We sat across from each other, and I mentioned "well that sounded like a fun conversation". His response was "yeah those motherfuckers don't know me".

- 11. He then asked me who was Gerawan. I told him it was a farming company in the Central Valley, whose employees, have been trying to get their ballots counted to decertify the UFW.
- 12. Mr. Hall then went on to tell me "Well those motherfuckers made a video about me, and I am going to get their ass".
- 13. Mr. Hall and I spoke for about 15 minutes, after this, about how he got involved in politics, and he informed me he was from Compton, and these types of things, and people don't intimidate him what so ever.
- 14. As we finished our conversation I asked him if he had a business card, in which case I could contact him, but instead he gave me his personal cell phone number, in which I called, then hung up so he could have my number, and I have his. That number is we spoke in a friendly, manner, which was not confrontational, whatsoever.

I hereby declare under penalty of perjury under the laws of the State of California that the foregoing is true and correct. If called as a witness I would testify competently to the foregoing facts.
